 - existing vegetation and trees on the land
- **Traffic Control Plan (Certified).** If a third party is to provide and install the TCP a current public liability insurance certificate of currency from the underwriter (insurance company) indemnifying the Hilltops Council shall be provided.
- **Current Public Liability Insurance Certificate** of Currency to the value of **\$20,000,000** (20 million dollars) from the underwriter (insurance company) indemnifying Hilltops Council to be provided by the contractor undertaking the works.
